Located in Royal Precinct of Phnom Penh, Cambodia, the **Hyatt Regency Phnom Penh** will comprise a 250 key **5-Star hotel,** centered around a historic 2 storey colonial house which will serve as main entry lobby. Developed by Cambodian developer Chipmong Ritta, the Groundbreaking Ceremony for the 14 storey with GFA of 45,000 sq.m. project took place on 22 March. Meinhardt is providing full C&S and MEP engineering design services for this luxury development which is expected to be completed by 2020.
