THE RIGHTS OF PERSONAL DATA SUBJECTS AND THE LEGALITY POLICY

The Company respects the right to privacy and pays attention to personal data. The Company has a policy of not collecting data without consent or it is lawful to collect personal data, including:

- to achieve the objectives related to the preparation of historical documents or archives for public benefit or related to research studies or statistics which have provided appropriate safeguards to protect rights and liberties;
- 2) is necessary to prevent or suppress a danger to the life, body or health of a person;
- 3) is necessary to perform the contract to which you are a party of or for use in the processing of your request before entering the contract;
- 4) is necessary for the legitimate interests of the Company or those of other persons or juristic persons unless such interests are less important than your fundamental rights to your personal data;
- 5) is for your benefit and the request for consent could not be made at that time;
- 6) is for the benefit of the investigating officer's investigation or the trial of the court;
- 7) is in compliance with laws such as Labor Protection Law, Computer Law, Accounting Law, Revenue Law, Anti-Money Laundering Act, Anti-Bribery Act, Occupational Health, Safety and Work Environment Law, Civil and Criminal Code, Civil and Criminal Procedure Code, etc.

Also, in the collection of personal data, the Company has a policy to provide a basis for the justification of collecting personal data including having a policy regarding a privacy notice.
